**Group Terms and Conditions**

- 1) Only food & beverage product supplied by StoneRidge Golf Club will be allowed on property. Food & Beverage arrangements must be completed two weeks prior to the event with the StoneRidge F&B Director.
- 2) All tournament and banquet fees will be paid the day of the event. If you require billing our terms are net 30 days. Any balance of any event invoice older than 30 days is subject to a 5% late fee.
- 3) All outings estimate their number of players with this contract. This estimate represents the maximum possible number of players you will have. StoneRidge requires a guaranteed number of players 14 days in advance. Your 14-day guarantee can be reduced from the original estimate by no more than 20%. The 14-day guarantee is the minimum number of players you will be charged for on your tournament date.
- 4) Failure to give StoneRidge a 14-day estimate will cause the group to be cancelled with no refund of any deposits. Any cancellation within 90 days of the event will receive no refund of any deposits.
- 5) Pairings must be made available 48 hours prior to your day of play. If you have fewer than 120 players, your group may share the course with other golfers.
- 6) Tournament and Hole Sponsors must adhere to sponsor guidelines provided by StoneRidge.
- 7) Return signed contract with deposit by the Due Date listed below. Tournament Date is guaranteed upon receipt of contract and deposit.
- 8) If your outing requires more than 72 carts an additional charge of \$35 per extra cart will be added to your event invoice.
