

STONERIDGE GOLF CLUB MEMBERSHIP AGREEMENT

This Membership Agreement describes the membership rights and obligations of the undersigned individual or individuals ("Member", whether one or more) to StoneRidge Golf Club, Inc. ("StoneRidge").

1. **Term.** Membership is on an annual renewable term basis. Your membership runs from the date this Agreement is signed ("Effective Date") to March 31st ("Annual Renewal Date"), and will automatically renew for the next succeeding twelve month term unless the Member provides the StoneRidge Board of Directors with written notice of termination at least sixty (60) days prior to the Annual Renewal Date, in which case the membership will terminate at the end of the current term.
2. **Classes of Membership and Fees.** Memberships are classified as either: (a) Single, defined as one individual; or (b) Couple, defined as a Member and their spouse or child under the age of 23. Single Members age 34 or younger qualify for Junior Executive pricing. Couples qualify for Junior Executive pricing provided the older of the two Members is age 34 or younger. Junior Executive eligibility is based upon the Member's age on the Effective Date or Annual Renewal Date, as applicable. Junior Members must pay Membership Fees in an Annual Lump Sum. Members who do not qualify for Junior Executive pricing may either pay Membership Fees in an Annual Lump Sum or on a Monthly Payment Plan. Current rates for each option are listed below. Membership fees on the Monthly Payment Plan are due and payable in advance. Monthly membership statement terms are Net 15 days and require a valid Credit Card Payment Guarantee Form on file. A MEMBER ACCOUNT THAT IS 30 DAYS PAST DUE MAY RESULT IN LOSS OF BENEFITS UNTIL THE ACCOUNT IS BROUGHT CURRENT. Membership fees are subject to modification upon 180 days' notice, at the option of the Board of Directors of StoneRidge. Notice will be effective on the date mailed to the address listed below or last known address.
3. **Benefits of Membership.** Membership benefits include unlimited play when the course is open to general play, full range privileges at the "Members Only" range, use of locker room facilities, GHIN handicap, reduced guest fee, reduced cart fee, discounts in the golf shop, and other benefits. In addition, Single and Couple members (not Junior Executives) receive one full locker, bag storage (one per member), and waived rental charges on banquet and meeting rooms.
4. **Miscellaneous.** You will be provided a membership packet outlining the StoneRidge club rules upon execution of this Agreement. Members are required to follow StoneRidge club rules, membership rules, and standards of golf etiquette. Failure to follow these rules and standards may lead to termination of your membership at the discretion of StoneRidge Board of Directors. Membership may also be terminated if membership fees or account balances become more than thirty days past due. If membership is terminated without full payment of the financial obligations of the Member, StoneRidge may recover the delinquent amount from the Member, together with interest at eight percent per annum and all costs of collection, including actual attorney's fees, and costs incurred by StoneRidge. This Agreement is made in Minnesota, and Member agrees that Minnesota courts, without a jury, may resolve any dispute associated with membership at StoneRidge.
